Per Florida Statutes 98.075, to receive information regarding the basis for potential ineligibility, you should contact the Supervisor of Elections office no later than thirty days after the date of this publishing. If you deny the accuracy of the information underlying the potential ineligibility, you have the right to request a hearing for the purpose of determining eligibility.

If you attempt to vote at an early voting site or your normal election day polling place, you will be required to vote a provisional ballot. If you vote by mail, your ballot will be treated as a provisional ballot. In either case, your ballot may not be counted until a final determination of eligibility is made. If you wish for your ballot to be counted, you must contact the supervisor of elections office within 2 days after the election and present evidence that you are eligible to vote.

This notice is being published on April 10, 2026. Failure to respond could result in a determination of ineligibility by the Supervisor of Elections and your name could be removed from the statewide voter registration system. Según el Estatuto 98.075 de Florida, para recibir información sobre los motivos de una posible inelegibilidad, debe comunicarse con la oficina del Supervisor de Elecciones a más tardar treinta días después de la fecha de esta publicación. Si niega la exactitud de la información subyacente a la posible inelegibilidad, tiene derecho a solicitar una audiencia con el fin de determinar la elegibilidad.

Si intenta votar en un sitio de votación anticipada o en su centro de votación habitual el día de las elecciones, se le pedirá que vote con una papeleta provisional. Si vota por correo, su boleta se considerará como papeleta provisional. En cualquiera de estos casos, es posible que su papeleta no se contabilice hasta que se tome una determinación final de elegibilidad. Si desea que su papeleta se contabilice, debe comunicarse con el Supervisor de Elecciones dentro de los 2 días posteriores a la elección y presentar evidencia de que es elegible para votar.

Este aviso se publicará el 10 de abril de 2026. Si no responde, el Supervisor de Elecciones podría determinar su inelegibilidad y su nombre podría eliminarse del sistema de registro de votantes de todo el estado.
